#### Facility, Check-In, Briefings and Walk-Throughs

\*Please note: All Dogs Gym does not allow flexi leads in the building for safety purposes.
Please come prepared with a regular, non-adjustable lead.

Trial times: Judges briefing and walk-throughs at 7:30 am. First dog on Start line at 8 am. Start time for Trial 2 is estimated and will begin after Trial 1 is completed, but no earlier than 1:00 p.m. Each trial will start with Puppy & Level 1. Levels 2, 3 & Veterans to follow.

All Dogs Gym doors will be open at 7am. Please do not arrive prior to this time. Please respect our residential neighbors, and comply with Manchester's Noise Ordinance which includes no barking dogs prior to 7 am. We appreciate your cooperation.

Dogs may be crated in the facility. Chairs are available to competitors.

Judge's briefing and walk-throughs will precede each trial.

Move-ups will be allowed between trials both in level and class.

Food and beverages will not be provided on site. Area restaurants and fast food are within a short driving distance of the trial site.

#### Directions to the Show Site:

All Dogs Gym is located just outside the Manchester Airport, just two miles from Route 93 and the Everett Turnpike.

ROUTE 293/101: Take South Willow St exit for Mall of NH. Go ¾ mile past Mall of NH, staying in left hand lane. At the fork, bear left, and then take left at blinking yellow light onto Sheffield Road. All Dogs Gym is ahead on the right.

93N: Exit 5. Left at bottom of exit towards Manchester. Go 3.5 miles to blinking light (past The Yard restaurant). Turn right onto Sheffield Road.

93S: From North of Manchester, take 293/101W and follow 293 directions above. From South of Manchester, take exit 5. Take right at bottom of exit and follow directions for 93 N above

#### **Rally Obedience Description**

**APDT Rally encourages participation by ALL dogs – purebred or mixed breed, pets or titled champions.** Handlers are allowed to encourage their dogs in the ring using verbal praise, petting, and even food rewards at the completion of a stationary exercise before they begin to move to the next exercise just as they would in a good training session. The dogs must perform the exercises correctly and there should be a practiced smooth flow to the performance.

Rally courses, depending on the competition level, consist of 18 to 22 stations, laid out in a numbered pattern (like an agility course), performed on-leash in Level 1 or off-leash in Level 2 and Level 3 (Level 1 title is required to compete at Level 2, Level 2 title is required to compete at Level 3). Also like agility, handlers get to walk the course and familiarize themselves with the pattern without their dog before running the course. During their run, the dog and handler move through the course in heel position, performing each exercise in turn. The highest scores will be earned by teams who move smoothly through the course, completing each exercise accurately with a minimum of commands, and with high enthusiasm and good attitude. Praise and/or verbal encouragement upon completion of exercises are allowed, and extra commands during exercises are minimally penalized. Rally is fun and interesting to watch as the individual style of each team can really show through.

There are as many as 58 different stations, which might be seen in a Rally course, primarily variations on basic heel exercises and other Obedience skills. Many of the stations involve activities you are probably familiar with; such as Slow/Normal/Fast Pace Heel, Halt, Left/Right/About Turn, and Finish Right/Left. Others are simple extensions, such as 270° and 360° Right/Left Turns, Straight Figure Eight, and Send over Jumps.

This Rally-O titling event will allow competitors a chance to earn legs or points toward Rally-O titles. APDT Rally allows all breeds and mixed breeds to compete and is committed to encouraging positive training methods. The APDT is an organization for professional dog trainers with almost 6,000 members worldwide. It was founded in 1993 with the mission of

enhancing the human-dog relationship by educating trainers, other animal professionals and the public and advocating dog-friendly training. For more information visit www.APDT.com.

\*You must be familiar with all of the different Rally-O exercise signs prior to the event. Go to www.apdt.com/rallyo/index.htm for an explanation of each of the exercise signs and have fun practicing them with your dog.

#### **Puppy and Veterans Classes**

Veteran Level is open to all dogs over the age of 8 with a valid APDT Rally registration number. A Veteran Level course will consist of 12 exercises from any Level, plus Start, Finish and a Bonus Exercise from any Level. Please see the APDT Rally Rules and Guidelines Chapter 7 for more info on Veterans Level regulations.

Puppy Level is open to all puppies between the age of 6 and 12 months. A Puppy Level course will consist of 10 Level 1 exercises, plus Start, Finish and a Bonus exercise. Please see the APDT Rally Rules and Guidelines Chapter 6 for more info on Puppy Level regulations.

#### Level A & B Classes

Level A classes are for teams that have not yet completed their title at that level. Level B classes are for teams that have already completed their title at that level.

#### **Jump Heights**

Dogs are not required to be measured the day of the trial or prior to judging. However, judges have the option of measuring any dog prior to his/her performance if the dog appears to be entered in a group lower than might be indicated by his or her registered shoulder height. Jump heights may also be modified or the jump exercise excused entirely based on physical challenges (such as age, body type, or disability such as blindness or the use of a "mobility device") that a particular dog may face.

- Shoulder height under 12 inches.....Jump 4 inches
- Shoulder height 12 inches to under 16 inches......Jump 8 inches
- Shoulder height 16 inches to under 20 inches ......Jump 12 inches
- Shoulder height 20 inches and over ......Jump 16 inches



#### **Notice to Competitors**

Competitors, through submission of entry, acknowledge that they are knowledgeable of APDT Rally Obedience rules and regulations including but not limited to the following rules regarding entry:

- This trial is open to all dogs being at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- All dogs must be registered with APDT Rally to compete. A one-time registration form is included and must be submitted DIRECTLY to the Rally-O Coordinator (NOT to trial hosting organization) before the date that a team first submits an entry in a sanctioned trial. We regret we cannot accept an entry without a valid APDT Rally registration number.
- Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.
- Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- The organizing committee may refuse any entry for any reason.
- THERE SHALL BE NO REFUND for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check where notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse by owner/handler.
- No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.
- All dogs shall be shown in a flat buckle or snap collar, plain harness, or properly fitted martingale (limited slip)
  collar. No choke collar, prong collars, shock collars, no-pull harnesses, martingale leads, or head collars are
  allowed.
- All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. All video, broadcast, and telecast rights for this event are the exclusive property of the APDT or the trial host(s).
- Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- Dogs with disabilities are allowed and encouraged to compete provided that the dog does not show evidence of being in pain or discomfort.
- Upon successful completion of an exercise, the owner may choose to briefly pet or touch the dog as a reward. The owner may also choose to give the dog food as a reward. Food may NOT be used as a lure to help the dog complete an exercise. Food rewards must be contained in pockets or hidden treat pouches and only be present in the owner's hand in between exercises. Any petting, touching, or feeding that significantly interrupts the flow of performance shall be scored accordingly.
- Exhibitors may use food as a reward in the ring upon completion of any stationary exercise. Veteran and Puppy classes allow food rewards to be used more liberally.
- Dogs must remain under control at all times whether on or off leash while on show grounds. Day kenneling only is permitted, unless otherwise posted at the show site. **Crates may be left overnight at your own risk in crating**
- Please pick up after your dog and yourself.
- This event will be held indoors on rubber flooring.
